

Symposium Collaboration details

- Sponsored 1 hr session.
- The sponsor may propose a structure and topics focused on their own brand products as long as it adapts to the given time and the general objectives established by the Congress Organizing and Scientific Committees.
- Both the content and the speakers of the symposium must be previously approved by the Organizing Committee.
- The costs incurred by speakers and moderators (registration, travel, accommodations and fees) will be covered by the sponsoring company. These are NOT included in the collaboration price. The technical secretariat may coordinate these items and bill them directly to the sponsors if they wish.
- The room includes projection and basic sound and the room set up (theatre set up) can't be change.
- Food and beverage inside the room is not permitted. If you have a Symposium before the Lunch break (12:30 -13:30) remember that a lunch box is included for all attendees. If you'll like to have a special lunch or give any food or drink related to the attendees, this needs to be given after the symposium outside of the room.
